FYI, our meeting with the Smith County GIS Consortium was well received. Their Chairman, Bill Morales, Dir. Of Smith City 911, stated in a follow up call that it was excellent. We will be bidding on the aerial mapping for all of Smith county this next month, and we believe the odds of winning are quite high. Should we win and capture all of the county at 6" resolution (same resolution we used to comply with our AGIS mapping for KDUA), could you see where the airport could benefit? On another note we are about to perform a test that I believe you will find intriguing. We call it "Pencils on the Pavement"... we will be capturing our runway here at KJDD and scattered on the runway will be a handful of #2 pencils. Our mapping will be so detailed we hope to show you our ability to see each on clearly... measuring their width, depth, and length. ("What we measure... we manage.")

I would welcome your review of the same and to let us know if this capability has merit for payment management issues.
